



Overview of the Process

Step 1: Get Accustomed to the App



- Download the app
 - TIP: If you are having trouble on the app move to your desktop (www.StoryCorps.me) to create an account



Overview of the Process

Step 2 & 3: Interview Prep



- Choose who you will interview
 - TIP: For your first interview it may be best to find someone you interact with on a regular basis
 - TIP: Print and provide the **Information for Interviewee and Consent Form** (page 3-4 of the toolkit) a few days before the interview.
- Arrange a day, time, and quiet place to interview your community member.

Overview of the Process

Step 4: Interview Day



- On the day of the interview:
 - Review/use the **Interviewer Guide & Example Script**, which provides sample interview questions
 - ✦ TIP – Determine which questions you would like to ask prior to the interview
 - ✦ TIP – Review the questions with the interviewee before recording

Overview of the Process

Step 4: Interview Day



- Complete Interviewee release forms
 - Obtaining consent
 - ✦ Review out loud with the interviewee the information in the **Information for Interviewees and Consent Form** (page 3-4 of the toolkit)
 - ✦ TIP: If you are interviewing during your work day, it would be prudent to obtain consent from your employer as well.

Overview of the Process

Step 4: Interview Day



Photo/Audio Tape/Video Tape Release Form

As part of the End Hunger in America – Stories from Across Our Nation project, the Academy of Nutrition and Dietetics requests the use of photographic/audio/video material. We specifically ask your consent to use this material as we deem proper. These materials may be used for news releases, reports, professional publications, professional conferences, websites, advocacy efforts and pictorial exhibits to promote the End Hunger in America – Stories from Across Our Nation project. The Academy does not have the ability to remove the material posted to the public website (<https://storycorps.me/>)

I consent to the recording of my statements and grant to the Academy of Nutrition and Dietetics it's assigns, licensees, and successors the right to copy, reproduce, and use all or a portion of the statements (the "Interview") for all purposes, including advertising, trade, or any commercial purpose throughout the world and in perpetuity. I grant the right to use my image and name in connection with all uses of the Interview and waive the right to inspect or approve any use of my Interview.




Step 5: Upload your Story

- ✦ Optional key words:
SNAP, WIC,
SchoolLunch, Nutrition,
Hunger

Step 6 & 7: Share your Story




- **Send us your stories!**


